Position Summary:

Blackwell Consulting Ltd. is seeking a Forest Professional to join its team as a Project Lead. The role involves planning and coordinating forestry and silviculture projects, including timber valuation, silviculture practices, forest fertilization, forest health, forest development, and fuel management. Training will be provided as necessary. Duties will consist of both fieldwork and office work, which include:

- Timber appraisals/tenure valuation and related analysis
- Ecological data collection, site identification, fuel type assessment
- Forest health assessment
- Stand assessments for fertilization, density management and rehabilitation
- Forest management field work
- Technical reporting and prescription development
- Treatment implementation and supervision
- Project planning and management
- Fuel management

Blackwell's main office is based in North Vancouver, with potential consideration for other work locations such as Vancouver Island or the B.C. Interior. The position requires travel throughout B.C., including remote areas. Fieldwork may involve shifts lasting up to a week or 10 days during the field season (excluding remote camp assignments). The role may involve physically demanding tasks, exposure to different weather conditions, and requires schedule flexibility.

Required Qualifications:

- Registered with the ABCFP or eligible for registration as a Forest Professional;
- Minimum 5 years of forestry experience;
- Possess a valid class 5 BC Driver's License;
- · Strong interpersonal communication, technical report writing, and editing skills;
- · Leadership abilities, a dedicated work ethic, and a commitment to ongoing growth and learning; and
- Legal status to work in Canada and fluent in English.

Preferred Qualifications/Assets:

- Forestry field experience. Preference will be given to candidates with experience in operations and planning including harvesting and road construction, silviculture, fuels management/wildfire management, fire suppression, forest health;
- Understanding and interpreting financial data, documentation, and reports;
- Conduct data analytics using Microsoft Excel pivot tables and statistical tools;
- Proficiency using B.C. stand-level analytical tools (E.g., TIPSY, Woodlot, TAAS, VDYP);
- Experience with ArcMap, SNAP, Avenza Maps, and Microsoft Office; and
- Experience working around trucks, ATVs, and snowmobiles, including driving manual transmission vehicles and forestry resource roads:
